Per Missouri Department of Elementary and Secondary Education requirements for admission / exit from a Teacher Education Program, no minimum cumulative GPA is required. However, a minimum 3.0 GPA (with no grade lower than a C) in the content area and in professional education coursework is required for candidates seeking middle, secondary, or K-12 content area certification and a minimum 3.0 program GPA (with no grade lower than a C) is required for candidates seeking early childhood, elementary, or special education certification. Per Missouri statute, proficiency in general education through performance on an accepted entrance exam is required for admission into the MBU Teacher Education Program for degree-seeking undergraduate students. As of October 2022, DESE has allowed the following exams to satisfy the testing requirement for proficiency in the areas of math, reading, and communication set forth in Missouri State Statute 168.400. MBU minimum required scores are as shown: ACT Composite Score 20 SAT Composite Score 1040 Paraprofessional Composite Score 220 MoGEA subtest 068 – Mathematics 200 MoGEA subtest 066 – Reading Comprehension & Interpretation 202 MoGEA subtest 067 – Writing 193 Undergraduate degree-seeking students who are pursuing teacher certification and matriculate with an ACT composite score of 20 or higher (or an SAT composite score of 1040 or higher) have met MBU’s qualifying scores. Students who have not met these benchmarks may take either the Missouri Paraprofessional exam or MoGEA to fulfill the testing requirement for proficiency. The Paraprofessional or MoGEA must be taken in the same semester as EDUC 201 Professional Growth and Folio Development I (second semester of the sophomore year or first semester of enrollment for students transferring with a class rank of junior or higher). While the Paraprofessional exam, like the ACT and SAT, has a passing composite score, students must achieve a passing score on each of the MoGEA subtests as listed in the chart above.

8. Describe your institution's most successful strategies in meeting the assurances listed above:

All Missouri Baptist University (MBU) teacher candidates take the course EDPS 453/553: The Exceptional Child, in which they learn about a broad range of student learning differences and how to support them in the general education classroom. The course includes a 6-clock hour field experience in a special education classroom, execution of multiple case studies in which candidates plan classroom and instructional support for students with different disabilities, and a culminating project in which they design and implement a general education lesson plan with extensive accommodations and support for specific students with one or more disabilities. MBU requires all candidates seeking initial teacher certification to complete the course EDUC 203: Teaching in a Diverse Society, which is required early in their program to make them aware of a broad range of student characteristics, while reflecting on their own diverse perspectives as well. A 10-clock hour field experience with English language learners (ELL) is included in the

course EDRD 423/523: Integrating Literacy in the Content Areas, which is required for all candidates seeking initial teacher certification. A significant number of Missouri Baptist University's students come from low income, rural areas outside of the St. Louis area and many of them complete field experiences in those environments and return to those environments to teach following completion of their certification. All teacher certification candidates take a course (EDUC 373: Technology and Instructional Media for undergraduate students, and EDUC 573: Applications of Technology as an Effective Tool in Teaching and Learning for post-baccalaureate students) that requires them to explore and apply a variety of types of current instructional technology to enhance PK-12 teaching and learning. Candidates learn to identify and integrate varied, appropriate technologies both to enhance teacher productivity and professional practice and to apply the technologies into curriculum and instruction to enhance learning experiences for diverse students. This course, as well as multiple special education courses, also introduces students to components of universal design for learning (UDL). Throughout their program, candidates are required to integrate appropriate technology into lesson and unit plans that they develop, starting with EDUC 303 Methods of Teaching and Differentiated Instruction at the beginning of their program. The course ECTA 323: Curriculum, Assessment, and Data-based Decision Making is a requirement for candidates seeking initial teacher or library certification (with the exception of K-12 health, music, and PE majors, who have this content embedded in their content methods courses). This course provides an introduction to theoretical and practical applications of data-driven decision-making, assessments, and curriculum planning for educators, including applying these concepts to personalized instruction for a broad range of PK-12 students. Multiple courses in initial certification programs require candidates to examine and analyze data from the Missouri Department of Elementary and Secondary Education (DESE) website in an effort to strengthen PK-12 teaching and learning. All candidates examine multiple sets of class assessments to analyze the data and use the data to drive future instruction. MBU also offers a Master's degree in Educational Technology for teachers who wish to further develop their educational technology expertise.

#### a. Teach students with disabilities effectively

All Missouri Baptist University (MBU) teacher candidates take the course EDPS 453/553: The Exceptional Child, in which they learn about a broad range of student learning differences and how to support those differences in the general education classroom. The course includes a 6-clock hour field experience in a P-12 special education classroom, execution of multiple case studies in which candidates plan classroom and instructional support for students with different disabilities, and a culminating project in which they design and implement a general education lesson plan with extensive accommodations and support for specific students with one or more disabilities. Candidates also learn about the RTI / MTSS process for connecting students with tiered interventions and using monitoring procedures to measure student growth. Content exploring evidence-based practices with MTSS is purposefully integrated into several literacy courses taken by candidates in general education and special education programs. In addition, candidates learn about behavior and classroom management for children with special needs, including characteristics of children with a range of special needs, specific instructional support techniques, the importance of structures / routines, behavioral contracts, behavior modification, the role of commonly used programs such as PBIS and ABA, and setting appropriate behavioral expectations in the course ETOP 423/523 Classroom and Behavior Management and other coursework.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Every teacher candidate is introduced to IEPs in EDPS 453/553: The Exceptional Child and gains further exposure in other courses throughout the curriculum, as appropriate for their certification area. As part of this work, candidates learn the components of IEPs, review multiple IEPs for students with a range of disabilities, and execute multiple case studies in which they act as various members of IEP teams. Candidates also complete a culminating assignment in which they write annual IEP goals for a specific K-12 student with disabilities, then tying those goals to both a general education lesson plan for that student's class and personalized instruction techniques tailored for that student.

#### c. Effectively teach students who are limited English proficient.

Teacher education candidates receive instruction on how to effectively teach students who are limited in English proficiency (ELL) in courses including EDRD 423/523: Integration of Literacy in the Content Areas, ELED 453/553: Integrated Language Arts Concepts for PK-6, and EDRD 443/543: Analysis and Correction of Reading Disorders, in addition to various courses in the Special Education program. A 10-clock hour field experience with ELL students is included in EDRD 423/523: Integration of Literacy in the Content Area, specifically focused on observing and working with students who are limited in English proficiency in a P-12 classroom. Additionally, through both course content and related assessments, students conduct a variety of real-life classroom and parent-related scenarios using multiple modalities. This course/field experience is required of all students seeking initial teacher certification.

**a. Teach students with disabilities effectively**

Special education (SPED) candidates begin by taking the course EDPS 453/553: The Exceptional Child, in which they learn about a broad range of student learning differences and how to support them in the general education classroom. The course includes a 6-clock hour field experience in a special education classroom, execution of multiple case studies in which candidates plan classroom and instructional support for students with different disabilities, and a culminating project in which they design and implement a general education lesson plan with extensive accommodations and support for specific students with one or more disabilities. Candidates also learn about the RTI / MTSS process for connecting students with tiered interventions and using monitoring procedures to measure student growth. SPED candidate coursework continues with 15 hours of field experience in EDSP433 Methods of Teaching and Inclusion for Students with Cross-Categorical Disabilities, as well as an additional 15 hours for early childhood SPED candidates in the ECSP 403/503 Introduction to Early Childhood Special Ed and ECSP 413/513 Teaching Young Children with Disabilities courses. Throughout this coursework, candidates develop skill in applying personalized assessment strategies for the improvement of student learning, as well as collaboration techniques for team teaching. Content regarding evidence-based practices with MTSS is purposefully integrated into several literacy courses taken by candidates in special education programs. In addition, candidates learn about behavior and classroom management for children with special needs, including characteristics of children with a range of special needs, specific instructional support techniques, the importance of structures / routines, behavioral contracts, behavior modification, the role of commonly used programs such as PBIS and ABA, and setting appropriate behavioral expectations, in both their special education coursework and the course ETOP 423/523 Classroom and Behavior Management. Finally, SPED candidates complete the course ECSP 423/523 Family Engagement and Partnership, which emphasizes strategies for developing strong and effective collaborative relationships specifically with families of students with special needs, with an emphasis on collaboration, partnerships, and a family systems approach.

**b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.**

Special education (SPED) candidates are introduced to IEPs in EDPS 453/553: The Exceptional Child. As part of this work, candidates learn the components of IEPs, review multiple IEPs for students with a range of disabilities, and execute multiple case studies in which they act as various members of IEP teams. Candidates also complete a culminating assignment in which they write annual IEP goals for a specific K-12 student with disabilities, then tying those goals to a general education lesson plan for that student's class. As SPED candidates continue through their program, taking a variety of SPED methods courses and early literacy courses, they gain more extensive exposure and practice with components of IEPs. They become competent in applying assessment strategies for the improvement of student learning, including state-mandated assessments which may be utilized as part of the IEP process. Other related course topics include classroom management and social skills development, educational technology for learning disabled and behavior disordered students, collaboration techniques for team teaching, working with IEP teams and agencies, and effectively communicating and partnering with parents.

**c. Effectively teach students who are limited English proficient.**

Teacher education candidates receive instruction on how to effectively teach students who are limited in English proficiency (ELL) in courses including EDRD 423/523: Integration of Literacy in the Content Areas, ELED 453/553: Integrated Language Arts Concepts for PK-6, and EDRD 443/543: Analysis and Correction of Reading Disorders, in addition to various courses in the Special Education program. A 10-clock hour field experience with ELL students is included in EDRD 423/523: Integration of Literacy in the Content Area specifically to observe and work with students who are limited in English proficiency. Additionally, through both course content and related assessments, students conduct a variety of real-life classroom and parent-related scenarios using multiple modalities. This course/field experience is required of all students seeking initial teacher certification.
